

Minutes of the Finance & General Purposes Committee held on Monday 21 February 2022 at 6.30pm

22/172C Presentation for a Financial Grant:

(i) Seed of Hope – paperwork circulated prior to the meeting via Appendix 1.1

Kris Scotting gave a background of the Seed of Hope CIC and how it is a social enterprise helping people with mental health problems to change their lives through Recovery based Social and Therapeutic Horticulture. There are three groups held in Bridgwater, Watchet and Glastonbury, as well as a volunteer community gardening team. Seed of Hope reinvests money they make through selling goods and providing services straight back into the business and local community. This allows them to tackle social problems, improve life chances, support communities, and help the environment. The funding amount requested of £4,000 will help support the core costs of running the Watchet group.

There then followed a question-and-answer session on how many members from Watchet benefit and what the Watchet community garden project entails.

Cllr Murphy thanked Kris Scotting for his presentation and informed him that in accordance with the Councils financial policy for awarding grants, a decision would be made by the Committee at the next meeting.

Kris Scotting and Kate Radford left the meeting at 6.39pm

22/173C Presentation for a Financial Grant from the COVID Reserve:

(i) Knight Templar School – decision required in line with the Councils financial policy for awarding a COVID grant – paperwork circulated to members prior to the meeting via Appendix 1.2

Linda Bulpin, Chair of Governors gave a background on the inception of the swimming pool 35 years ago, and how it has provided and continues to provide vital swimming facilities to Watchet families, school children swimming, baby and toddler groups, private groups, disabled swimmers and aquafit. A breakdown of costs to maintain the pool were then listed and how essential maintenance to the heat exchanger had to be carried out or the pool would have had to close. During COVID the pool was closed and there was no income, and even though it was not permitted for use, it had to remain in a low gear operational mode as it could not remain dormant, and this has left a £ 3,400 deficit. To re-open this facility in full working order for the community after COVID restrictions were lifted has also left the school with an expected £5,000 repair bill. Any financial help the Council can give to allow the pool to be re-opened safely after COVID would be very much

Cllr Murphy proposed that the 'following recommendation is approved – delegation is given to the Clerk to arrange for one foxglove tree to be purchased at a cost of £35 to replace the commemorative yew tree in the Garden of Remembrance, and approval is given to a replacement plaque wording agreed, to be purchased at a cost of up to £50 from the Tourism & Leisure Platinum Jubilee budget'.
