22/189B Traffic Analysis Working Group:

Cllr Irven reported that there was not an update as the group had not met, but the Clerk had instructed Richard Fitter, Entran, that the Council wished to extend the consultancy fee period and continue to the engage his services in drafting a response to the Planning authority regarding the Cleeve Hill proposed development. As yet there had not been a response.

22/190B West Street Car Park:

- (i) To consider a change to the parking policy regarding caravans paperwork was circulated prior to the meeting via Appendix 1 after a brief discussion, Cllr Murphy proposed that 'the following amendments to section 23 are approved from 24 March 2022, Watchet Town Council will not be reallocating caravan spaces once they are relinquished by the current tenant. From this date, relinquished caravan spaces will be designated as car parking spaces'. Seconded by Cllr Irven. Carried with 4 votes for and 1 vote against.
- (ii) To consider comments made by a resident regarding management of the car park there followed a brief discussion, where members refuted the comments made and through a proposal by Cllr Johnson 'the Clerk is delegated to draft an appropriate response'. Seconded by Cllr Irven. Carried.
- 22/191B Direct bus to Taunton at peak times the Clerk reported that the letter as agreed at the last meeting had been drafted, but there had been some difficulty sourcing the contact details of the Manager of the Somerset area, but once the contact details were confirmed the letter would be sent.

22/192B Footpath at Seaview Terrace - update

Despite having chased up Savills, the agents acting on behalf of the Orchard Wyndham Estate, owners of the footpath, the Clerk reported that no response had been received, so there was no update to give.

Erection of 1 No. dwelling (resubmission of 3/37/21/032)

The Committee concur the reasons for refusal as follows 'the proposed dwelling is considered to constitute overdevelopment of the site and its form, scale and position within the site would have a detrimental impact on the existing street scene and represent a cramped form of development that does not make a positive contribution to local character. In addition, the development would result in material harm to residential amenity. It is therefore contrary to Policy NH13 of the West Somerset Council Local Plan to 2032, and the National Planning Policy Framework' and whilst members acknowledge that the resubmission does attempt to mitigate some of the grounds for refusal, the Committee do not think this is enough to enable them to change their opinion,

therefore the Committee objects to this application.
