22/186C Presentation for a Financial Grant:

Watchet Summertime - paperwork circulated prior to the meeting

Having declared a Personal and Prejudicial interest in this item, Cllr Irven withdrew from the meeting

John Fielding gave a background on the organisation and how a weeklong summer family event has been hosted mainly based on the Esplanade since 2010. The 2020 event was cancelled due to COVID and the 2021 event was ran at a reduced level. The 2022 event will run from 14 -20 August 2022 at full capacity, and will culminate a firework display and music show as the finale of the event on the Saturday evening. The grant request is for £500 for the following:

1. New re-usable banners - £150. The current banners are 10 years old; they will not be dispensed with but will be repaired and repurposed for signage.

2. The candle float event will no longer run and will be replaced by a 'Night of Light' which the Committee see as more ecologically friendly. This will involve illuminating the marina area in partnership with the Watchet Marina, local businesses, Watchet Boat Owners Association, and yachts visiting from the Bristol Channel Yacht Club Regatta. This will involve LED battery powered string lights to be purchased at a cost of £350.

John Fielding was thanked by the Chair for his presentation and informed that in line with the Councils financial policy, a decision will be made at the next meeting.
