Minutes of the Finance & Staffing Committee held on Thursday 22 September 2022 at 6.30pm

- 22/24C To Receive Apologies for Absence: (LGA 1972, section 85 (1)
 As Chair Cllr Murphy proposed that 'the apologies given by Councillors Campbell, Ellwood, and Ward are accepted'. Seconded by Cllr Whetlor. Carried.
