23/11C Financial Presentation for a Grant:

(i) Seeds of Hope –application and accounts circulated via **Appendix 2-** Co-founder of the CIC and another member gave some background to the not-for-profit social enterprise which helps to support people with mental health problems through recovery-based social and therapeutic horticulture. The group in Watchet comprises of up to 10 people, and the annual cost of running the enterprise is £15,000. The CIC is requesting a grant of £1,000. After a question-and-answer session, members raised queries with the groups accounts, and it was agreed that the Clerk would submit members queries for clarification purposes.

The members of the Seeds of Hope CIC were thanked for their presentation and informed by the Chair that a decision will be made at the next available meeting in line with the Councils financial policy.
