23/34D **Watchet Cemetery:**

Update on the breach in regulations- circulated via Appendix 2 -the Clerk reported the attached letter as agreed at the last meeting has been sent out to those deed holders who have been identified as breaching the Cemetery Policy. The Cemetery Administrator liaised with grounds staff and have ascertained that 74 in total are in breach. The breaches are in the main for laying plastic flowers on the graves. Since the ban of single use plastics on the 1 October 2023, the policy has been amended to include silk flowers. Staff will keep a monitoring brief on this matter to ensure that all breaches are addressed and resolved.

23/35D Watchet Library:

23/36C

To consider the purchase of a 'Sum-up' machine for card transactions - paperwork circulated via Appendix 3- the Clerk presented a quotation for a sum up machine, to enable Watchet Library staff to take card payments. It was agreed at the recent CLP meeting that Watchet Town Council would explore this purchase. Having communicated with the library staff, they do not need a machine that produces a receipt, so the 'Sumup Solo' is the recommended machine for this use. After a brief discussion, Cllr Murphy proposed that 'a budget of up to £90 is approved to purchase a 'Sum-up' machine'. Seconded by Cllr Whetlor. Carried.
