Liddymore Farm, Liddymore Lane, Williton, Watchet

Application for reserved matters following outline application 3/37/17/020 for the access, appearance, landscaping, layout and scale, with additional drainage strategy and levels, for the erection of 175 No. dwellings (Phases 2 and 3)

The Committee support the following comments made by Williton Parish Council:

- •There are only 18 visitor car parking spaces and these are not visible on plan
- There are only 2 parking spaces per dwelling
- •Sufficient electrical infrastructure should be installed for fast charging electric cars as there is no public transport.
- •Concerns regarding the width of the road, ensure larger vehicles and emergency services vehicles have access.
- •The plans have differed greatly from the original plans, there is one road of concern which may be leading to a possible building development in future.
- •Where will the affordable dwelling be located and to ensure a fair distribution between Williton and Watchet.

The Committee would also like to add the following additional comments: Watchet Town Council supports the report and conclusions of the Landscape Officer and in particular the summary and recommendations.

### SUMMARY

Partial objection with recommendations. There is no objection to the principle of development and proposed number of dwellings on the site, however, there are a number of concerns with the proposal as shown in this application, principally:

- Lack of strong street frontage.

- LEAP too far from the centre - undesirable situation.

- More details required on landscaping scheme.

- Lack of passive surveillance over landscaped areas.
- Cul-de-sacs inappropriate for residential developments.

#### **RECOMMENDATIONS**

Generally, it is strongly recommended that the SPD District Design Guide is used for principles of master planning, especially for creating strong street frontages. Additionally:

•Cycle storage should be detailed in the plans.

•The cul-de-sac along southern border should be connected to the road to the north (see red lines on figure 7.)

•The LEAP should be more centrally located.

•The landscaped area along the south/ south-east border should have passive surveillance with houses fronting on to it.

In addition to supporting the comments above The Committee recommends:

•A traffic analysis should be conducted to consider the impact on the local road network in Williton & Watchet, not just on the development. Please refer to Savills letter submitted on the original planning application 3/37/17/020

•The provision of dog waste bins on new developments must be addressed.

## 23/46B Allotment/West Beach subsidence:

(i) Update – *if required*Cllr Irven tabled photographs demonstrating the newly formed cliff edge and informed members that the allotments are still being monitored regularly and the new cliff edge is still within 3.5 metres of the harass fencing, so still within safety limits. Members noted the update.

(ii) West Bay Park – Licencing amendment clarification from Somerset Council - (*Paperwork circulated to members prior to the meeting via Appendix 2*)

Members noted a response from Somerset Council Licencing.

23/47B Watchet Yellow line road marking:

(i) Minutes of the yellow line road marking meeting held with S/C Highways on 11<sup>th</sup> October 2023 - (*Paperwork circulated to members prior to the meeting via Appendix 3*)

Members noted the minutes of the yellow line road marking meeting. Cllr Murphy informed members that the next stage will involve consultation via a Traffic Order before work can commence. Cllr Irven proposed 'to endorse the minutes'. Seconded by Cllr Moss. Carried.

## 23/48B Watchet Task Force:

(i) Update - *if required*Cllr Murphy informed members that the reconfiguration of harbour Road/Swain Street junction will commence from 27<sup>th</sup> November. Members noted.

Closed Cleeve Hill Cycle/pedestrian access
Cllr Moss informed members of a resident request to raise the requirement of a cycle/pedestrian access route on Cleeve Hill. Cllr Moss also reported the unsightly hedgerow as no longer being cut since the road closure. Cllr Murphy informed members that Somerset Council are currently working on options for a cycle/pedestrian access route, when there is any progress or further update it will be provided. Cllr Murphy agreed to refer the unsightly hedging/landscape to Watchet Task Force at their next meeting.

Liddymore Estate dog bin requirement – verbal update from Cllr Moss

Cllr Moss updated members to a concern from a new Liddymore Estate resident regarding the need for additional dog bin requirements. Cllr Moss proposed that 'a request is made to Somerset Council to express the need for additional dog waste bins in the new Liddymore Estate'. Seconded by Cllr Whetlor. Carried.

The Deputy Clerk informed members that during the recent Yellow Line road marking meeting held with Somerset Highways, members were informed that there are funding grants available for Speed Indicator Devices to help tackle speeding issues. Cllr Whetlor proposed that 'the Deputy Clerk is given delegation to apply for SID funding on behalf of the Council and contact is made with Avon & Somerset Police to request a DCB to be located on Brendon Road to collect data in preparation for additional future
