Minutes of the Environment & Planning Committee held on Wednesday 17th January 2024 at 6.45pm

Before the meeting commenced, a member of the public having given notice to speak during the public participation section, made a statement relating to planning applications 3/37/23/029 and 3/37/23/031 Parsonage Farm, Watchet on behalf of PFAG (Parsonage Farm Action Group) and as a resident.

During the public participation 2 members of the public arrived.

The Committee agreed to comment on both applications as one. Cllr Murphy provided further background on the development application and informed members that a meeting was held with Williton Parish Council earlier that clay to discuss the development. Williton Parish Council shared comments that had already been submitted on the Planning Portal, there were as follows:

Cllr Murphy commented that that the objections made by Williton Parish Council together with information provided by PFAG and their Planning Lawyer letter cover a great measure of points. A discussion ensued. Cllr Whetlor proposed that 'Cllr Irven be appointed to work alongside PFAG and attend to represent WTC at the planning meeting'. Seconded by Cllr Moss. Carried with 1 abstention.

A further discussion ensued. Cllr Irven proposed that 'the funds remaining in the budget for traffic analysis is, if deemed necessary, used to cover the costs of a traffic analysis on the Parsonage Farm development to compliment the opposing comments'. Seconded by Cllr Campbell. Carried.

Cllr Moss proposed that 'Watchet Town Council endorse the comments made by Williton Parish Council and support the statements made by PFAG and their Planning Lawyer. Cllr Murphy to draft comments for LPA submission'. Seconded by Cllr Richards. Carried with 1 abstention.

Cllr Whetlor thanked the PFAG for their continued hard work.
